# ASSOCIATE OF BUSINESS UNIVERSITY TRANSFER DEGREE (ABUS)

Scottsdale Community College (SCC), accredited by the Higher Learning Commission, offers the Associate of Business (ABUS) degree for students who plan to transfer to a university business program. Students earning the ABUS can transfer 62 credits to the university and be halfway done with a bachelor's degree in a business area.

The ABUS transfers without loss of credit to all Arizona state universities, as well as many others.

## THE ONLY DEGREE FOR TRANSFER

All students who want to transfer to a 4-year university business program must complete the ABUS.\* The ABUS is equivalent to the first two years of university business programs, regardless of the major of study.
