CERTIFICATES IN CANNABIS

Scottsdale Community College (SCC), accredited by the Higher Learning Commission offers three Certificates (CCL) in Cannabis. Students can earn all three certificates, plus an Entrepreneurial Studies Level I CCL in less than one year.

Students must complete CAN 101 before taking CAN 120, 125, 115, and 105.



CANNABIS BUSINESS FUNDAMENTALS

This certificate is designed to provide students with an introduction to the Cannabis industry.

This certificate is **NOT** eligible for financial aid.

COURSE	DESCRIPTION
CAN 101 Introduction to Cannabis Industry (3 credits)	Explores the historical, legal, social, and political aspects of cannabis use, cannabis careers and business planning.
CAN 110 Social Equity & Current Issues (1 credit)	Social equity programs, trends, current issues, and the societal impact in the cannabis industry.
CAN 120 Legal & Regulatory Environment (3 credits)	Study of cannabis industry laws, policies, regulations and ethics in non-use, medicinal-use, and adult-use.
CAN 125 Supply Chain Management (2 credits)	Management of cannabis supply chain stages from "seed to sale".

CANNABIS BUSINESS ADVANCED ENTREPRENEURSHIP

This certificate is for students who wish to start their own cannabis business. Students will earn both the Cannabis Business Fundamentals and the Entrepreneurial Studies I certificate in addition to the Cannabis Business Advanced Entrepreneurial certificate.

This certificate is eligible for financial aid.

CAN 101, 110, 120, 125 (9 credits)	Cannabis Business Fundamentals Certificate.
CAN 105 Accounting Finance and Funding (2 credits)	Financing, funding, accounting, capital ventures and tax practices unique to the cannabis industry.
CAN 115 Human Resources and Operations Management in Cannabis Industry (1 credit)	Workforce development and human, facilities, and capital management in the cannabis industry.
EPS 150 Introduction to Entrepreneurship (3 credits)	Overview of the entrepreneurial process and the skills required to be successful in business.
EPS 160 New Venture Creation (2 credits)	Process of starting a new venture including evaluating specific business opportunities, financing, and defining start-up issues.
EPS 195 Business Start-Up and Planning (2 credits)	Development of a feasibility approach to strategic decision making and business planning for a new venture start-up.
GBS 132 Personal and Family Financial Security (3 credits)	Principles and practices of personal and family financial planning.

CANNABIS BUSINESS ADMINISTRATION AND MANAGEMENT

This certificate is for students who wish to gain employment in an established Cannabis business. Students will earn both the Cannabis Business Fundamentals and the Cannabis Business Administration and Management certificates.

CAN 105 Accounting Finance and Funding (2 credits)	Financing, funding, accounting, capital ventures and tax practices. unique to the cannabis industry.
CAN 115 Human Resources and Operations Management in Cannabis Industry (1 credit)	Workforce development and human, facilities, and capital management in the cannabis industry.
MGT 175 Business Organization and Management (3 credits)	Basic principles of managing quality and performance in organizations.
ACC 109 or 110 or 111 or 211 Accounting course (3 credits)	Accounting and Financial concepts and principles.
GBS 151 Introduction to Business Or MGT 251 Human Relations in Business Or MGT 276 Human Resource Management (3 credits)	Overview of different areas of business. Motivation, leadership, communications, and other human factors which impact business. Planning, staffing, training, compensating, and appraising employees in organizations.
