Accountants and bookkeepers maintain the financial records for an organization. They are needed in every industry – manufacturing, retail, service, government, educational institutions, and hospitals.

Some activities include:

- Tracking and recording a company's expenditures and receipts
- Monitoring accounts payable and receivable
- Calculating profit and loss
- Preparing financial statements
- Calculating and preparing payroll
- Preparing tax documents and annual reports
- Assisting management in decision-making

If you're organized and enjoy working with numbers, a career as a bookkeeper could be a good fit. Bookkeeping requires specialized training in accounting essentials. A bookkeeping certification signals to employers that you have the training and knowledge to meet industry standards.

Scottsdale Community College (SCC), accredited by the Higher Learning Commission, offers the Certificate (CCL) in Certified Bookkeeping for students who wish to pursue a bookkeeping position with a small to medium-sized company. Students learn the basics of financial accounting and payroll accounting. In addition, accounting for depreciation for financial and tax accounting purposes, inventory valuation, and preventive internal control procedures are also covered. The CCL in Certified Bookkeeping program helps to prepare students for industry-recognized certified bookkeeper examinations. This program is designed to prepare students to work for CPA firms, tax preparation firms, corporate accounting departments, and small businesses or offer freelance bookkeeping services. The Certified Bookkeeping certificate leads into the Associate of Applied Science in Accounting.

CAREER OUTLOOK

Bookkeepers are constantly in high demand. According to the Bureau of Labor and Statistics, the median annual wage for bookkeeping, accounting, and auditing clerks was \$45,860.* The median wage is the wage at which half the workers in an occupation earned more than that amount and half earned less. The lowest 10% earned less than \$25,260 and the highest 10% earned more than \$61,650. Over 175,000 bookkeeping, accounting, and auditing clerk positions are expected to be available each year over the next decade. Clerks are expected to take on a more analytical and advisory role over the next decade.
