- Attended a GGIT (East Valley) event 2020–2024.
- Plan to enroll in 12 or more credits in the Fall 2025 semester at either Chandler Gilbert Community College, Mesa Community College, Rio Salado College, or Scottsdale Community College.
- Minimum 2.0 GPA (cumulative from high school, verified on transcripts).

- Online applications will be accepted through **Friday, May 23, 2025.**
- Once eligibility has been verified, applications will be reviewed and decisions will be announced in early June.
- The recipient of the \$1,000 scholarship will receive the funds into their Maricopa Community College student account at the beginning of the Fall 2025 semester.
- The \$1,000 is a one-time award and is not renewable. Recipient is welcome to apply for future GGIT awards.
